## Government of Canada's COVID-19 Economic Support for Charities

*The federal government has implemented programs for charities and non-profits in response to the COVID-19 pandemic.*

OTTAWA – There are several supports in place for charities and non-profits in response to the economic impacts associated with the COVID-19 pandemic. Information on some of these programs are outlined below.

### Emergency Community Support Fund (ECSF)

- The government invested \$350 million to support vulnerable Canadians through charities and non-profit organizations that deliver essential services to those in need.
- The investment will flow through national organizations that have the ability to get funds quickly to local organizations that serve vulnerable populations. It will support a variety of activities, such as:
  - Increasing volunteer-based home deliveries of groceries and medications;
  - Providing transportation services, like accompanying or driving seniors or persons with disabilities to appointments;
  - Scaling up help lines that provide information and support;
  - Helping vulnerable Canadians access government benefits;
  - Providing training, supplies, and other supports to volunteers so they can continue to make their invaluable contributions to the COVID-19 response; and
  - Replacing in-person, one-on-one contact and social gatherings with virtual contact through phone calls, texts, teleconferences, or the Internet.

### Supporting communities experiencing food insecurity

- Under the Food Policy for Canada's Local Food Infrastructure Fund, the Government of Canada is making up to \$100 million available to Canadian food banks and other national food rescue organizations to help improve access to food for people experiencing food insecurity in Canada due to the COVID-19 pandemic.
- Funds will be used to: purchase food and other basic necessities; buy or rent equipment and materials; transport and distribute food; access new distribution centres; hire temporary help to fill volunteer shortages; and, implement biosecurity measures.
